

### **Guidance Notes for completion of evidence questionnaire re Causeway Farm**

Our application relates to the use of the land over the last 20 years preceding 03-March-2010. The date at the end of the questionnaire, on page 5 can still be the current date, and if appropriate you can say that use of the land is ongoing.

You may sign jointly with other members of your household, or submit separate questionnaires if you prefer.

Please do NOT refer to any extraneous issues such as potential development etc as this application is solely based on recreational use of the land.

Use should not be of the one footpath on the land (Hangers Way) but other parts of the land, for example to and from gates backing on to the land.

To help with specific questions:

Q1. Your addresses at the time you have used the land (it could be more than one)

Q2. Address when you first used the land.

Q3a. Please also attach the map, which can also be downloaded. On the back please ensure that you add " This relates to the evidence provided by me" adding you name, signature and current date.

Q3b. If you cannot print the edging in red we will add this before submission.

Q4. If your house is shown on the map please mark it.

Q5/6. Pre-populated as Causeway Farm, but please feel free to change it.

Q7/8 Please enter approx from/to dates

Q9. Pre-populated with Yes. Please change if incorrect.

Q10. Pre-populated with Yes. Please change if incorrect.

Q11. Pre-populated, but please feel free to change.

Q12. Pre-populated with Yes, which refers to the Hangers Way footpath

Q13. Pre-populated with the main access from The Causeway, but please feel free to change.

Q14. Please indicate your reasons for going there e.g. walking, playing, wildlife observation, quiet, convenient etc.

Q15. State how often you use the land, other than the main path.

Q16. Refer to the list in Q23

Q17/Q18. Important to detail use by your entire family/household if that is the case.

Q19/Q22 Detail any activities you may have seen by groups such as Scouts/Guides etc

Q23 This refers to what you have seen happening on the land.

Q24-Q27 Just put your own knowledge/experience

Q28-30a It is to our advantage to state that no permission has been sought or given.

Q31 This is also key in that there has been no fencing, notices or similar stating that the land is private.

Q32/33 Please include any photos you have clearly marking them on the back with date, where taken and who is in the photo, if you know.

Q34 Please provide any additional relevant information, but as mentioned only related to the recreational use of the land.

Q35. Please let us know rather than add names here.

Q36. Please complete the number of years that you have used the land. Lawful origin simply refers to the fact that your use of the land hasn't been challenged.
